NOTICES OF INTENT (NOIs)

Notice of Intent (NOI) Conditions

All Restricted Material Permits must have a certified applicator, either private or commercial, and an Alternatives Worksheet for each type of restricted material. Before a California restricted material may be applied for agricultural use, a notice of intent must be submitted to the County Agricultural Commissioner's Office (CAC). The purpose of the NOI is to provide specific and critical information that was not available at the time the preliminary permit was issued.

The Fresno CAC is required by the State of California to review all NOIs to assure all required information not previously provided on the preliminary permit is included; to determine whether the information on the NOI is consistent with that on the permit; and whether any environmental conditions have changed since the permit was issued. To allow the CAC adequate time to review all NOIs received, the California Code of Regulations requires that the NOI be submitted to the CAC at least **24 hours** prior to the use of a pesticide requiring a permit.

- For applications intended to be applied on Saturdays and Sundays, or on Monday before noon, the NOI is due by noon on the previous Friday.
- For applications intended to be applied on a holiday, the NOI is due by noon of the previous working day.
- A **96-hour** NOI is required for the following fumigants: methyl bromide, metam sodium, metam potassium, chloropicrin, and 1,3-Dichloropropene.

If the application is being made by a licensed and registered pest control business, the business is responsible for NOI submittal.

Notice of Intent (NOI) Waivers

Waivers must be approved by the Pesticide Use Enforcement Deputy in writing and will only be approved in extenuating circumstances. Written approval must be obtained before commencing the application.

Sensitive Site - As described by labels and permit conditions, sensitive sites are areas frequented by non-occupational bystanders (especially children). These include residential lawns, pedestrian sidewalks, outdoor recreational area such as school grounds, athletic fields, parks, and all property associated with buildings occupied by humans for residential or commercial purpose. Sensitive sites include homes, farmworker housing, certified producer and small specialty crop on-site structures, schools, daycare centers, nursing homes, and hospitals.

2025 Fresno County Field Fumigant Permit Conditions METAM POTASSIUM and METAM SODIUM

All permittees who apply to have Metam on their restricted materials permit, all handlers, and any PCA's who write recommendations for Metam use shall attend and pass an AMVAC/TKI Metam Stewardship Training course, approved by the Agricultural Commissioner, annually. This is in addition to the soil fumigant training program requirement stated on the label.

For Use by Certified Applicators Only

Certification includes possession of one the following:

- Qualified Applicator License (QAL) Category L (Soil Fumigation)
- Qualified Applicator Certificate (QAC) Category L (Soil Fumigation)
- ❖ Applications are prohibited within ½-mile of any **difficult to evacuate site** as defined on the label, stated below, and any other sensitive site or residential area designated by the commissioner.
- ❖ Check label and regulation restrictions on fumigation methods that are in effect May 1 through October 31.

NOTICE OF INTENT (NOI)

NOIs must be submitted at least **96 hours** prior to the proposed application.

The NOI must include:

- Application depth and fumigation type, including 4-digit Field Fumigation Method (FFM) code.
- A detailed map indicating structures and **sensitive sites* surrounding the application site
 - Show the distances from the application site to sensitive sites
 - Identify wells, structures, and all adjacent surrounding crops.
 - Identify adjacent property operators
 - Neighboring properties requiring notification and/or signed agreements must be numbered to correspond with the notification log.
 - Measurements must be made from the edge of the application block to the property lines of all the surrounding properties. These measurements must be on the map. If any portion of a residential property is to be used as part of the buffer zone, the distance to the residence must be included on the map.
- Buffer Zones
- The broadcast equivalent and number of applications
- A copy of the site-specific Fumigation Management Plan (FMP)
- Written permissions to allow buffer zones to extend into adjoining agricultural property

Difficult to Evacuate Sites

These include state-licensed day care centers, Pre-K to Grade 12 schools, nursing homes, assisted living facilities, hospitals, in-patient clinics, prisons, and residential areas (10 or more occupied structures or 3 or more occupied structures on 2 acres or less within a 1/2 mile of the application block). The Fresno County Commissioner measures these distances to the property line.

Occupied Structure

Is a home or other building that may be occupied for any or all parts of a 24-hour period. This includes buildings where people may work for limited periods of time, such as barns, equipment sheds, pump houses, workshops and certified producer's specialty crop on-site structures.

Sensitive Site

As described by labels and permit conditions, sensitive sites are areas frequented by non-occupational bystanders (especially children). These include residential lawns, pedestrian sidewalks, outdoor recreational area such as school grounds, athletic fields, parks, and all property associated with buildings occupied by humans for residential or commercial purpose. Sensitive sites include homes, farmworker housing, certified producer and small specialty crop on-site structures, other residential areas (10 or more occupied structures or 3 or more occupied structures on 2 acres or less within a 1/2 mile of the application block), schools, daycare centers, nursing homes, and hospitals.

Fumigation Management Plans (FMP)

The certified applicator must provide the property operator a copy of the FMP and supplemental documents used to fulfill FMP requirements. Both the certified applicator and property operator must keep FMP records for two years.

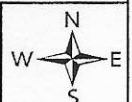

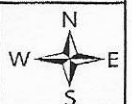

W. LINCOLN AVE & S. AMADOR AVE

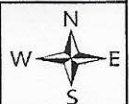

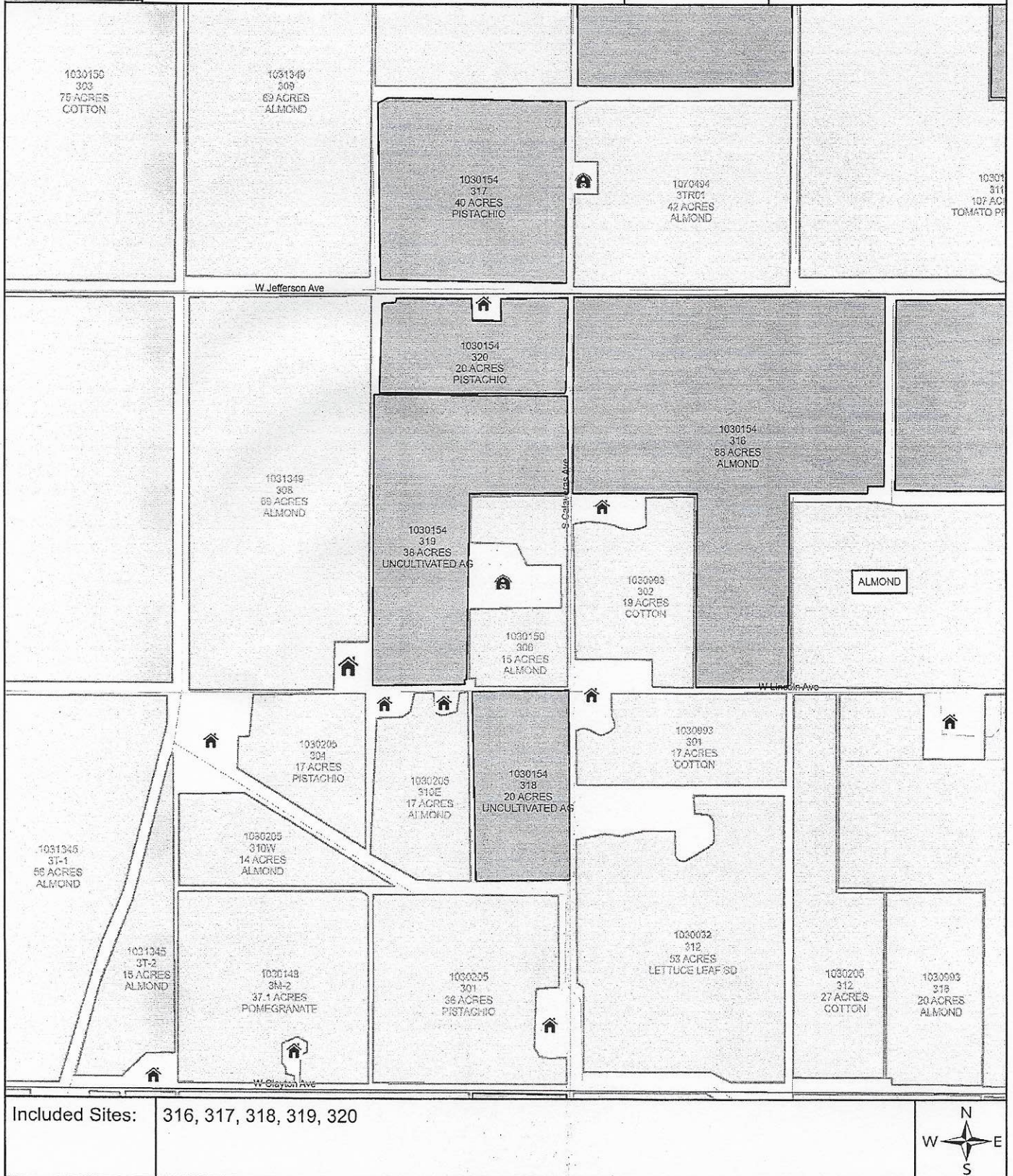

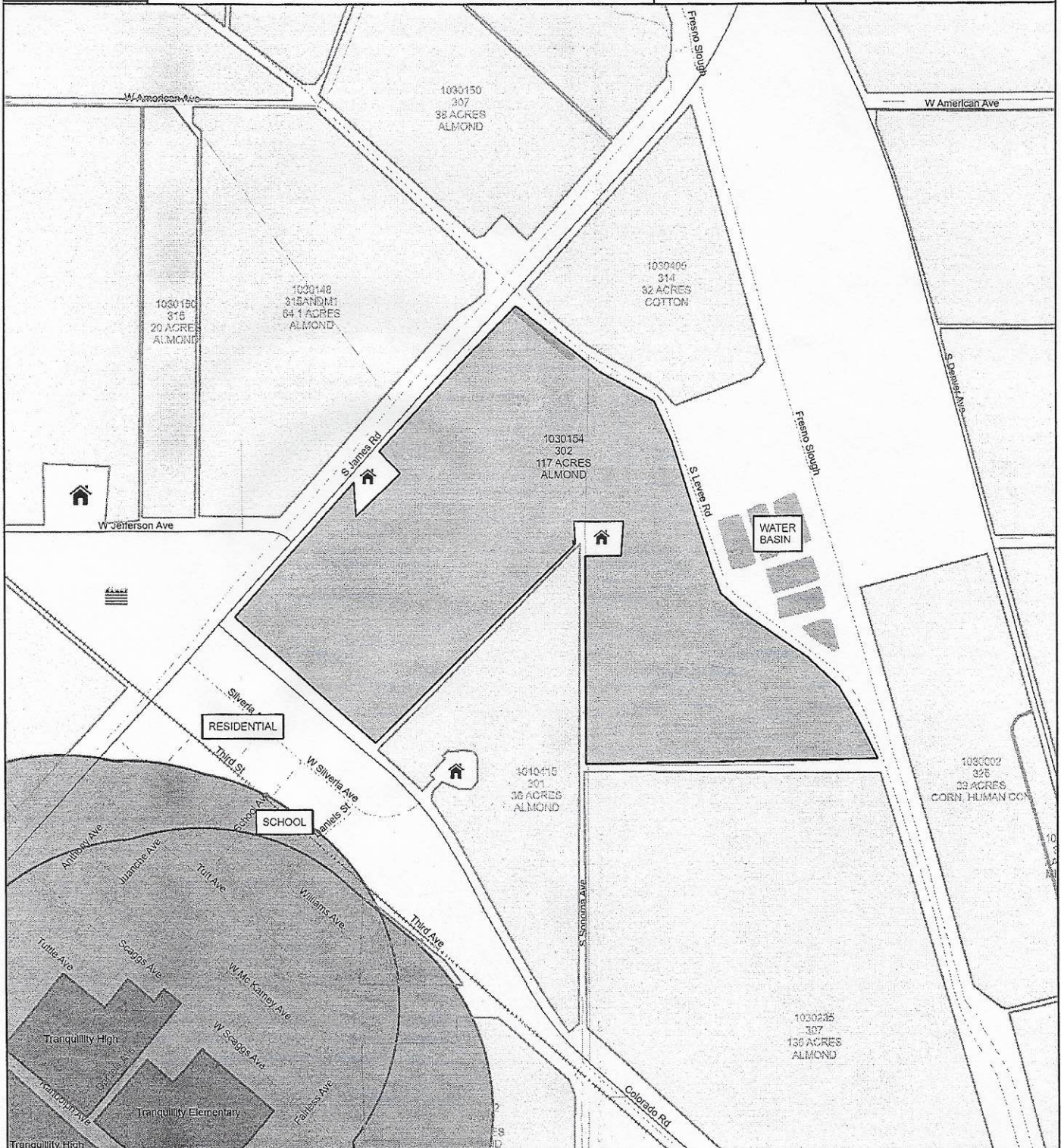
MAP 5
