CODE OF ETHICS POLLINATOR PARTNERSHIP (P2)

I. Integrity

All directors, officers, employees, and volunteers of Pollinator Partnership (P2) shall act with honesty, integrity, and openness in all of their dealings as representatives of Pollinator Partnership (P2). Pollinator Partnership (P2) shall maintain a working environment that values integrity, fairness, and respect.

II. Mission and Vision

Our mission is to increase the impact of nonprofit community-based organizations and the people who work and volunteer in them.

We pursue our mission by:

- Delivering a range of high-impact capacity-building services to community-based organizations and the individuals working and volunteering in them,
- Continuously refining these services based on what clients tell us they need and our own informed experiences in the field,
- Staying abreast of and helping to shape current best practices and paradigms in nonprofit capacity building.

III. Governance

The Board of Directors is responsible for setting the mission and the strategic direction of Pollinator Partnership (P2) and for exercising oversight of its finances and policies. The Board of Directors shall:

- Ensure that Board members possess the requisite skills and experience to carry out their duties and that all directors understand and fulfill their governance duties, acting for the benefit of Pollinator Partnership (P2) and its public purpose;
- Adopt and implement a Conflict of Interest Policy so that conflicts of interest, as well as the appearance of conflicts of interest, are avoided or properly managed through disclosure, recusal, or other means;
- Be responsible for the hiring and regular performance review of the Executive Director, and ensure that the compensation of the Executive Director is reasonable and appropriate;
- Ensure that the Executive Director and appropriate staff provide the Board of Directors with timely and comprehensive information so that the Board of Directors can effectively carry out its duties;
- Ensure that Pollinator Partnership (P2) conducts all transactions and dealings with integrity and honesty;
- Ensure that Pollinator Partnership (P2) promotes working relationships with Board members, management team, staff, and volunteers based on mutual respect, fairness, and openness;

- Ensure that Pollinator Partnership (P2) is fair and inclusive in its hiring and promotion policies and practices for all Board, management team, staff, and volunteer positions;
- Ensure that key policies of Pollinator Partnership (P2) are in writing, clearly articulated, and adopted;
- Ensure that the resources of Pollinator Partnership (P2) are responsibly and prudently managed;
- Ensure that Pollinator Partnership (P2) has the capacity to carry out its programs effectively.

IV. Law and Ethics

Pollinator Partnership (P2) shall comply with all applicable federal, state, and local laws and regulations and shall seek the advice of counsel when necessary or appropriate. Compliance with the law, however, is the minimum standard of expected behavior.

Pollinator Partnership (P2) shall also adhere to the highest ethical standards. All resolutions and other legal actions by the Board of Directors shall satisfy two requirements: (1) they shall be legally permissible, and (2) they shall also reflect the highest ethical standards as determined by the Board of Directors in the exercise of its sole discretion.

V. Stewardship

In managing its funds responsibly and prudently, Pollinator Partnership (P2) shall:

- Devote a reasonable percentage of its annual budget to programs in pursuance of its mission;
- Incur administrative costs adequate to ensure effective accounting and legal compliance systems, internal controls, competent staff, and other expenditures critical to professional management;
- Pay compensation, in return for services, that is reasonable but not excessive;
- Avoid accumulating Pollinator Partnership (P2) funds excessively;
- Draw prudently from restricted funds in a manner consistent with the restrictions;
- Follow spending practices and policies those are fair, reasonable, and appropriate to fulfill the mission of Pollinator Partnership (P2).

VI. Diversity

Pollinator Partnership (P2) shall promote diversity and inclusiveness in its Board of Directors, management team, staff, and volunteers.

VII. Evaluation

Pollinator Partnership (P2) is committed to improve, continually, its public programs and its organizational quality. Pollinator Partnership (P2) shall periodically review its program and incorporate lessons learned into future programs. Pollinator Partnership (P2)

shall be responsive to new developments in its field of activity and shall be responsive to the interests of its audiences and other constituencies.

Pollinator Partnership (P2) shall develop and implement a three-tier evaluation procedure whereby the performance of the Board of Directors as a whole, each Board committee, and each director is evaluated periodically.

VIII. Fundraising

Pollinator Partnership (P2) shall comply with the fundraising requirements of California's Nonprofit Integrity Act of 2004. Pollinator Partnership (P2) shall respect the privacy concerns of individual donors and shall follow donor intent in making expenditures. Pollinator Partnership (P2) shall disclose important and relevant information to potential donors. In raising funds from the public, Pollinator Partnership (P2) shall:

- Inform donors of the mission of Pollinator Partnership (P2), how resources will be used, and the integrity of Pollinator Partnership (P2) causing donations to be used effectively for their intended purposes;
- Inform donors of the identity of those serving on Pollinator Partnership (P2)'s Board;
- Disclose Pollinator Partnership (P2)'s most recent financial reports;
- Represent that contributions will be used for the purposes for which they were given;
- Provide appropriate acknowledgement and recognition of contributions;
- Treat information about donations with respect and with confidentiality to the extent provided by the law;
- Provide an opportunity for donors to delete their names from mailing lists that may be used by others;
- Encourage donors to ask questions when making a donation, and provide prompt, truthful, and forthright answers.

IX. Transparency

Pollinator Partnership (P2) shall provide comprehensive and timely information to the public, the media, and all stakeholders and shall be responsive in a timely manner to reasonable requests for information. All information about Pollinator Partnership (P2) shall fully and honestly reflect the policies and practices of Pollinator Partnership (P2). All solicitation materials shall accurately represent Pollinator Partnership (P2)s's policies and practices. All financial and program reports shall be complete and accurate in all material aspects.

The following governance documents shall be posted on Pollinator Partnership (P2)'s website:

Articles of Incorporation, Bylaws, Conflict of Interest Policy, Code of Ethics, Gift Acceptance Policy, Whistleblower Notice and Policy, and Document Management Policy, along with audited financial statements and Form 990 for the most recent three years. The website shall invite comments by readers with regard to any governance document, and the readers shall be expressly encouraged to download any documents that may be useful to their nonprofit organization.

X. Confidentiality

All directors, officers, employees and volunteers have a duty to safeguard information that is proprietary to Pollinator Partnership (P2). Information about Pollinator Partnership (P2) that is confidential or proprietary and obtained by a director, officer, employee or volunteer as a consequence of such person's association with Pollinator Partnership (P2) may not be disclosed to third parties unless expressly authorized by Pollinator Partnership (P2).

XI. Complaints

Any person, whether or not connected with Pollinator Partnership (P2), may lodge a complaint of unethical conduct against a director, officer, employee, or volunteer of Pollinator Partnership (P2) by filing such complaint, written or oral, with any director or officer.

XII. Remedies

Any director who fails to comply with this Code of Ethics may, in the discretion of the Board of Directors, be removed from the Board. If any employee or volunteer fails to comply with this Code of Ethics, that person may be put on notice or terminated, in the discretion of the Executive Director or the Board of Directors.

XIII. Annual Affirmation Statement

Pollinator Partnership (P2) shall provide a copy of this Code of Ethics to every director, officer, employee, and volunteer. Each year the Annual Affirmation Statement, attached, shall be signed by each director, officer, and employee, affirming that such person has received a copy of this Code of Ethics, has read and understands it, and agrees to comply with it. Volunteers are not required to sign and submit such a Statement.

All Annual Affirmation Statements shall be submitted to the Executive Director or the Secretary of the Foundation and then filed with the minutes of the first meeting of the Board of Directors held each year after January 31.
